



TOURNAMENT TEAM PLAYERS AND PARENTS COMMITMENT LETTER 2015-2016

November 1, 2015

Our/My child has been invited to play on a tournament team for the 2015-2016 Season. We/I understand that our/my child's continued participation is contingent on our/my participation as outlined below. We/I explicitly acknowledge and agree that we/I will share in the volunteer responsibilities associated with the team. Specifically, we/I agree that we/I will:

Player and Parent Commitments

1. Prioritize attendance at all team events (including practices and games) over other sports and weekend/afterschool activities from the beginning of the tournament season through the end of the tournament season;
2. Make all advance payments necessary within 5 days of being requested by our coach and/or team administrator;
3. **Volunteer up to 10 hours per player at the Beverly Hills Sportsmanship Cup in whatever capacity requested.** We/I understand that it is possible I may miss one of our team's games during the tournament;
4. **Volunteer to referee at each tournament we/I attend, assuming we are/I am a certified referee.** If we are/I am not a certified referee, we/I will volunteer to help at each tournament I/we attend as requested by the team coach or team administrator. **We/I understand that we/I will volunteer for at least 10 hours per child** during the tournament season, not including the Sportsmanship Cup.
5. Be a role model for my/our child, behave in a manner consistent with AYSO philosophies and AYSO Kid Zone guidelines and be a good personal ambassador for our Region;
6. Not criticize any decisions by tournament officials or referees in any manner whatsoever;
7. Comply with all Tournament Rules and requests by Tournament officials for tournaments I/we attend;
8. Accept all decisions by the team coach, including but not limited to decisions affecting playing time and position for our/my child as well as game tactics and strategy;
9. Accept all rulings and decisions by the Regional Commissioner and Post Season Tournament Director as final, subject to the published guidelines for Region 76; and,
10. Ensure our/my child attends all team practices and tournaments, except in the case of illness or injury. In the event of injury or illness, we/I agree to inform the coach sufficiently in advance of any practices or games that our/my child cannot attend.

Consequences of Non-Compliance

Further, we/I agree that our/my failure to honor any of the commitments above may result in the following consequences, subject to published Regional guidelines:

1. Reduction in playing time for our/my child;
2. Excluding our/my child from participation at certain tournaments;
3. Suspension of our/my child from the team;
4. Loss of eligibility of our/my child for future tournament teams; and,
5. Having our/my attendance at tournaments restricted or suspended.



We/I acknowledge and agree that I have had the chance to review the Region's full rules and guidelines regarding tournament team coaches and players and for the conduct of such teams as set out on the Region's website (<http://www.ayso76.org/PostSeason/index.cfm>).
